

A financial assistance initiative provided by an organization, government, foundation, or corporation to support individuals, groups, businesses, or other entities in achieving specific goals or objectives. Typically, grant programs are:

- **Purpose-Driven**: Awarded to fund activities aligned with the grantor's mission or objectives
- **Eligibility**: Programs have specific eligibility requirements that must be met



- Competitive or Non-Competitive: Open to all applicants, or select invitees
- Reporting Requirements: Grantees are required to provide updates on progress, impacts and financials







A common application can be tailored to the program needs, or changed from year to year or cycle to cycle

Helpful Information



Common Application

- Start with a common set of fields for all application types or programs (standard and custom fields)
 - ID
 - Organization
 - Applicant Name
 - Status
 - Type
 - Project Title
 - Project Description
 - Amount Requested

Customized Fields and Field Behavior



- Use the Call record business rules to add new fields specific to that call
 - Eligibility Questions
 - Review Criteria
 - Narrative Questions
 - Select Value Questions (dropdown, checkbox, radio button)
- Customize instructions for certain fields
- Change the validation rules
 - Maximum Request Amount
 - Grant Term
- Change parameters for data tables such as Budgets



Button and Status Rules

- Skip steps in the business process
 - No eligibility status
 - No external review
 - Streamline application process for rapid response
- Add steps in the business process
 - Add executive review
 - Add payment contingencies



Activity Creation Rules

- Specify the number and frequency of activities needed
 - Progress Reports
 - Site Visits
- Require or exclude final reports
- Specify the number of external reviewers required and when to create review records
- Specify the number and frequency of payments
